Convene

Presiding Commissioner John Grubaugh called the meeting of the County Commission to order at 8:30 a.m. on May 1, 2008 at the County Commission Office. Attendance: John Grubaugh, Absent: Bill Barnett, Present: Tom Huff, Present.

8:30 a.m. Terry Hill and David Appleby -- Bud Springs Road (Stoneshire Special District)

Those present for the meeting were: Lori Biery, Mike Blankenship with Tire Centers, Common 2 Road District Supervisor, Brent Young, Donna Osborne from the Christian County Headliner, and Brad Dunn, Ozarko Tires.

The Commission met with Terry Hill and David Appleby to discuss the Terry Hill's property on Bud Springs Road. Mr. Hill has submitted an application for a building permit to build a home on Bud Springs Road. The Planning and Zoning Department needs a letter confirming Bud Springs Road was originally platted in the Stoneshire Special Road District and is not maintained and was never accepted as a county road. Mr. Hill and David Appleby had a copy of the minutes from a previous meeting showing that Bud Springs Road was not maintained and was not accepted as a county road. According to David Appleby, the other alternative is a petition. The Commission suggested that Mr. Hill should contact the Stoneshire Road District for a letter of verification to submit to Planning and Zoning because the Commission does not oversee Stoneshire Special Road District.

9:30 a.m. Bid Opening for Cutting Right-of-Ways for Common 1 and Common 2 Road Districts

The Commission opened 1 bid for Vaught and Company. The bid was for cutting brush at \$ 57.50 per hour.
