10:00 a.m. Lagers retirement non-contributory option

Those present for the meeting were Ted Nichols, Sheriff Robertson, Roy Meadows, Karen Matthews, Carol Frank, Amy York, Jamie Matlock, Pat Wright, Suzanne Frakes, Susan Asher, Linda Failla, John Bross, Tom Lawson, Cindy Bilyeu, Darian Caplinger, Jean Niehoff, Danny Clinton and Sam Yarnell.

The Commission met with William R. Schwarts Director of the LAGERS Retirement System to discuss the reimbursement options to county employees that paid into LAGERS in prior years. According to Mr. Schwarts the Director of LAGERS, once the county elects to become non-contributory after a 2 year period the county can elect to refund the contributions to the employees. This would be done by a court order. Essentially LAGERS pays out the money to the qualifying employees approximately 60 days later. It does not effect the benefit amount of premium that is currently paid. Taxes were paid on the contributions and the interest would be taxable unless it is rolled over into an IRA or other qualifying retirement account. LAGERS pays interest on employees contributions once each year. Selecting September 1 as the effective date of the refund would allow receipt of this year's interest. The intent of the Commission to pass the court order must be posted a minimum of 45 days prior to the effective date. Adoption of this resolution has no effect on the current retirement benefit program selected.

Presiding Commissioner, Grubaugh requested, in addition to the contribution refund option, that Mr. Schwarts provide information on the cost of increasing the level of our retirement program . The Commission will take it under advisement and the Health Department will also review the information . Ted Nichols asked, "What if the County says yes and the Health Department would have to agree and the health department can separate from us

Mr. Schwarts outlined possible solutions if the Health Department choose an option different from the county.

Pat Wright would be interested in getting the refund because she had to pay the full 16% and was the only one that did pay the full amount.

11:00 a.m. Melissa Cook - Aire Master - Restroom Cleaning Proposal

Melissa Cook of Aire Master presented an itemized proposal to the Commission for cleaning and sanitizing the bathrooms at the court house, judical center, and both road barns. John entertain a motion to accept Aire MAster's pricing for restroom sanitation services and paper products for the bathrooms in the courthouse the judicial centers, and the road barns with the additional deep cleaning services.
