8:30 a.m. Public Hearing 2008 Amended Budget

Those present for the meeting were Treasurer, Karen Matthews.

The Commission met with Auditor, Sam Yarnell for the amended budget hearing. The 2008 budget was amended to reflect three natural disasters which will partially be reimbursed by FEMA. In addition, the County changed Worker's Comp carriers earlier this year. The new Building Inspections Department has just got underway and the budget will reflect the changes in that department. The budget was amended to more accurately reflect the revenues and disbursements within the county funds. Presiding Commissioner, Grubaugh entertained a motion to accept the 2008 amended budget.
