The Commission met with Treasurer, Karen Matthews, Collector, Ted Nichols, Commission Secretary, Lori Biery, County Counselor, John Housley Norma Ryan, Chief Deputy Clerk, Assistant Prosecutor Donovan Dobbs and Dan Mathenia from Ozark Bank to discuss the banking depository agreement.

The independent auditor made a recommendation for a new bank depository agreement. The Treasurer has worked over a year on the banking agreement and the document was reviewed and approved by Andy Marmouget, the independent auditor. The agreement was for the Treasurer, County Clerk, and the Prosecuting Attorney. Presiding Commissioner, Grubaugh, liked the agreement particularly section 7.2 but he wanted to have the agreement to be inclusive of all the elected officials. The Treasurer wanted the

agreement to be signed but the Commission could not agree. Western Commissioner, Barnett requested that they approve the agreement for the three office holders and the other office holders could create their own. County Counselor, John Housley was going to contact other elected officials to include them in the depository agreement. The Commission scheduled a meeting for June 16th with the officeholders to discuss the banking agreement.

Collector Nichols made the suggestion of having internet read-only provided to the County Auditor. He also wanted to know about the withdrawal of funds in the banking agreement . In the past, the Collector had funds withdrawn from his account without his knowledge .
