Center Road Posting No Parking Signs 9:15 a.m.--

WHEREAS, The Commissioners of Christian County, Missouri find and declare that it is necessary to establish parking restrictions on Center Road at the slab, in order to provide the safe and efficient movement of traffic on County maintained roads within Christian County, Missouri;

THEREFORE, BE IT RESOLVED by the Christian County Commission, as follows:

1. It shall be unlawful for any person to park a motor vehicle on Center Road at the slab, a County maintained road located within Christian County.
2. This Ordinance shall be effective as of July 24, 2008.


Motion/Vote - Appointments to the Senior Citizen Service's Fund Board
