## Convene

Presiding Commissioner John Grubaugh called the meeting of the County Commission to order at 9:00 a.m. on October 2, 2008 at the County Commission Office. Attendance: John Grubaugh, Present: Bill Barnett, Present: Tom Huff, Present. County Clerk Kay Brown is taking the minutes.

## 9:00 a.m. Petition to Vacate Road -- Bud Springs Road

Those present for the meeting were Commission Secretary Julia Maples.

The Commission received a petition to vacate Bud Springs Road from David Appleby. The application requires that it be read aloud during a Commission's session. The Presiding Commissioner, John Grubaugh read the following:

### APPLICATION TO VACATE A PUBLIC ROAD

COME NOW the undersigned, being all the owners of lots subject to the alleged public road known as "Bud Springs Road" in Stoneshire, First Addition, a Subdivision in Christian County, Missouri, and for their petition to vacate, state as follows:

1. That "Bud Springs Road" in Stoneshire First Addition, Christian County, is actually an old undedicated road as shown on the recorded plat of said Subdivision, was not constructed or dedicated to or accepted by the County, and is not in use by the public.
2. That, in fact, improvements (homes, driveways, and foundations) have been built on or across said "Bud Springs Road," and such alleged road is useless.
3. That the County, nor any road district herein, has maintained said, "Bud Springs Road" in the last thirty (30) years, and to construct and maintain said alleged road would be an unreasonable burden on Stoneshire Special Road District.

WHEREFORE, the undersigned request the Christian County, Missouri Commission to read this application on the first day of its next term; continue it until the first day of the following term; and, if there be no proper remonstrance made in writing, enter its order vacating the alleged public road described as follows:

All that part of "Bud Springs Road" as shown on the final recorded plat of Stoneshire First Addition, a subdivision in Christian County, Missouri.

The Commission opened one bid from P.C. Net for \$ 6,210.00 for a server for the Assessor's Office and the Collector's Office.


**Motion/Vote - Accept the Bid for a Server for the Collector and the Assessor**
