

# Christian County Commission

June 22, 2009

## Convene

Presiding Commissioner John Grubaugh called the meeting of the County Commission to order at 9:00 a.m. on June 22, 2009 at the County Commission Office. Attendance: John Grubaugh, Present: Bill Barnett, Present: Tom Huff, Present. County Clerk Kay Brown is taking the minutes.

## 9:00 a.m. Planning and Zoning Re: Administration Position

The meeting was attended by Commission Secretary Cindy Childress and Todd Wiesenhan Planning and Zoning Senior Planner

The Commission met with Resource Management Administrator Jim Bresee and Planning and Zoning Acting Administrator Bob Atchley. Presiding Commissioner Grubaugh stated that Mr. Atchley has been the Planning and Zoning Acting Administrator for a little over six months and has received an outstanding review. Presiding Commissioner Grubaugh suggested that Mr. Atchley be promoted to the position of Planning and Zoning Administrator. Mr. Atchley accepted the position title change without a salary increase. The Commission wanted to give a pay increase but due to the weak economy the raise has been suspended. Presiding Commissioner Grubaugh stated that Mr. Atchley has moved the department forward and has been working to make a clean transition to traditional planning and zoning for the county. The Commission appreciated the work that Mr. Atchley has done.

## Motion/Vote - Appoint Mr. Bob Atchley to Planning and Zoning Administrator

## 11:00 a.m. Donna Christian, MO. State Auditor's Office Re: State Audit Entrance Meeting

The meeting was attended by Commission Secretary Cindy Childress, Roberta Bledsoe, Michelle Crawford, David Olson staff from the State Auditor's Office, Recorder Roy Meadows, Treasurer Karen Matthews and Jim Bowles.

The Commission met with Donna Christian of the Missouri State Auditor's Office to begin the state audit of Christian County. Ms. Christian stated that a petition of 3,836 certified signatures were filed with the Missouri State Auditor's office and based on the law they are required to do an audit of the county. The cost of the audit will range from \$50,000.00 to \$ 60,000.00 unless they run into problems. The whole process will take eight to nine months and the county will be billed thirty days after the report is issued. The State Auditor will also be auditing the Circuit Court and Juvenile but will not be included in this audit. The scope of this audit is policies and procedures and more of a management audit not compiling numbers. Ms. Christian requested that a letter be sent to Davis, Lynn, and Moots to review their working papers from the audit. They will be looking at all the officials offices, the Senior Citizens Board and E-911. The library and

the health department are not included in the audit.
