9:00 a.m. King Block Re: Drug & Alcohol Testing Proposal

The meeting was attended by Commission Secretary Julia Maples and Chris Cluck of the Christian County Headliner News, Jim Bresee, Resource Management Administrator.

The Commission met with King Block of Tox Review LLC to discuss a proposal for drug and alcohol testing. Currently, the County uses Employee Screening Services for all drug testing. Mr. Block presented a proposal for drug and alcohol testing that meets the requirements of the Department of Transportation. Mr. Block stated that all tests are done on site and results are available within twenty-four to thirty-six hours. For screenings that test positive, they require a little longer time to process. The Commission will review the information.

10:00 a.m. Christian County Auditor Sam Yarnell Re: Budget Study Session

The meeting was attended by Commission Secretary Julia Maples, Recorder Roy Meadows, Treasurer Karen Matthews, and County Counselor John Housley.

Presiding Commissioner and Eastern Commissioner met with County Auditor Sam Yarnell and Chief Deputy Payroll Clerk Tom Lawson. Mr. Lawson presented the state holiday schedule for 2010 and made some budget suggestions. There was discussion that the year 2010 has 27 pay periods. The normal pay period for the county is 26 pay periods.

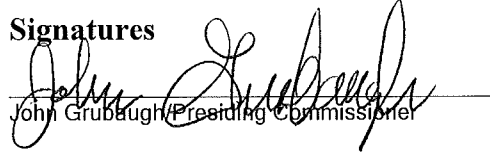
