The Commission met with Mr. Todd Wiesehan - Planning & Development regarding May 2015 Activity Report.

Mr. Weisehan discussed report as follow:

- -Update on end of April 2015 funds at \$26,092.47 approximately 3 times above the deposit amount from last year.
- -Building inspections permits increase from 73 permits = \$25,242.00 in April 2014, to 102 permits = \$43,291.00 in April 2015. Indication that our overall economic optimism, residential resurgence, regional development and strategies are working.
- -Currently have 10 minor subdivision applications submitted for approval.
- -Allen Global Headquarters is considering a site
- -Solar Farm issue will be on June 22, 2015 at 10:00 am at the P&D building.
- -County Commission's decision on Camp MeWe was upheld by the Judge as of April 27, 2015.
- -June 8th, 2015 would mark 40 days since judgment.
- -Department truck currently has approximately 125,000 miles considering trade in.
- -Submission of work order installing 3 air ducts post remodel, still not completed.
