Discussion - I.T. Contract

The meeting was attended by Commission Secretary Julia Maples, Prosecutor Amy Fite, County Counselor John Housley, Auditor Lacy Hart

The Commission met with Ms. Fite to discuss a proposal regarding the I.T. Contract

Ms. Fite began discussion regarding the urgency of IT services for both the Prosecutors office and Sheriffs office. A joint Investigator position was posted in Feb. 2015, currently there are 2 candidates qualified for the position. However in order to accommodate out needs we have received from PCnet an 8 month service contract. Mr. Housley and Ms. Hart have reviewed the contract and approve the services. Mr. Housley stated due to the Prosecutors office losing an IT person he found that PCnet services already in use within the county met the requirements. A bid was not necessary and placed a request for a proposal to then negotiate best solution for the county needs. Commissioner Childers asked if the sheriffs office is paying any percentage of the cost, Ms. Fite replied, no. Commissioner Barnett asked are we letting it go over \$4500.00, Ms. Hart responded she thinks we are covered. Ms. Maples commented if under \$6,000.00 no publishing is necessary. Commissioner Weter stated that due to the urgent nature of this matter we ought to approve an 8 month contract with PCnet which currently is thru Jan. 2016. Ms. Maples asked if the contract can be shortened to 7 months ending in December 2015. Ms. Fite will attempt to renegotiate contract to terminate in Dec. 31, 2015. Ms. Fite asked who is the source to go to for compliance issues? Commissioner Weter said Mr. Housley should be the person to go to. Mr. Housley responded that his status is to approve all contracts and not the renegotiation part of the deal, however the auditors role is involved regarding funds availability, he answers to the legalities, and for financial matters should go to Ms. Hart. Therefore if legal issue or financial they both have to be

approved. Commissioner Weter said the Auditor approves if funds are available, and Ms. Housley tends to legal issues. Ms. Maples stated that according to the Statutes Christian County makes the decisions for purchases, and decides what goes in contract, bids, proposals etc..., the B6 manual states the county commission office processes the proposals etc..., Mr Housley confirmed according to the B6 manual it states the contract goes thru the commission office. Commissioner Weter concluded meeting stating to renegotiate a change regarding the length of the contract from 8 months to 7 months and set another meeting to review. The next appointed meeting was set for June 4th at 9 a.m.

Consider this letter as formal written notification that the Christian County Commission voted today to terminate the lease agreement between Christian County, Missouri and EDI Plus, Inc. pertaining to the premises used by the Christian County Sheriff's Department as offices and a training facility, located at 1262 N. Kinder Street, Nixa, MO 65714. Pursuant to Section 3.2 of the lease agreement, the County Commission hereby gives EDI Plus, Inc. a 30 day notice of termination of the lease agreement, based on Steve Eidson's statement to the County Commission today, that he would waive the 60 day notice requirement and release the county from the lease of the premises effective June 30, 2015. The lease agreement will terminate on June 30, 2015. The County will pay rental to EDI Plus, Inc. for the month of June, 2015.
