Discussion - Law Enforcement Consultants Discussion

The meeting was attended by Commission Secretary Julia Maples, Amber with Headliner News, Mr. Steve Haefling consultant for Christian County Sheriff department, and Auditor Lacy Hart

The Commission met to discuss the Law Enforcement Consultant services.

Discussion began with Presiding Commissioner Weter stating the contract has not been submitted from Interim Sheriff Dwight McNiel, it is currently being prepared by Mr. Housley, and will be reviewed by Interim Sheriff Dwight McNiel, Mr. Joe Weber, Mr. Mike Robertson, Mr. Ron Hartman, and Mr. Steve Haefling to account for the assessment. Once all have reviewed we will schedule another meeting to have a discussion we currently don't have anything to discuss at this time. Once Counsel John Housley signs the contract then we can sign. Commissioner Childers asked if we have a copy of the contract? Commissioner Weter said we have a revised copy. On Friday Mr. Weber modified the contract and we only have a revised version. Commissioner Childers asked if Mr. Steve Haefling can have a copy for his review. Mr. Steve Haefling stated his purpose here is in regard to what happened in the Sheriffs Department, and he feels obligated to help and improve in some areas. Ms. Maples made a copy of the revised contract and gave to Mr. Steve Haefling. Mr. Steve Haefling said there are some issues that will need to be addressed in the sheriff's department regarding operational functions. Commissioner Weter said effective 7/1/2015 the utility tax for Law Enforcement Services will be implemented and we may see some revenue. Until then we can look at plans, however will need to wait until we have money available to spend. Mr. Steve Haefling responded there are matters that will need to be addressed right away. Commissioner Weter suggested that he look over the contract, and have Council
