Discussion - Department Update

The meeting was attended by Commission Secretary Julia Maples, Sheriff McNeil, Council John Housley, Amelia Wigton-Headliner News, Ms. Judy Dollarhite, 911 Director Rance Duffy, Linda Barger-Emergency Management

The Commission met with Sheriff McNiel to discuss the Sheriffs Department update.

Sheriff began by stating:

- 1: Discussed the retained services of Mr. Weber, how he addressed immediate concerns with jail practice violations. As of Friday we are in complete compliance with jail standards.
- 2: He had a meeting with the sheriff's department regarding the jail standards with prisoner process.
- 3: ICE and Marshall service has been reviewed, and the agreement we have with them was appropriate therefore no changes were needed to be made.
- 4: The County Sheriff's staff issues in regard to the Jail need to be corrected. Staff issues are a problem; we don't have enough staff scheduled accordingly, however the matter will be resolved and corrected in the next 24 hrs.
- 5: Sheriff McNiel found out that a prisoner is hospitalized due to a self inflited injury, the prisoner is being cared for at the counties expense.
- 6: As for the sheriff's department turn over; one reason is due to the low salaries, also turn overs are attributed to the moral within the sheriff's department which was low, also a need is to communicate with the officers in an orderly manner regarding prisoners. Commissioner Weter asked is the cat walk guard rail adequate? Sheriff McNiel they are, he noted Mr. Weber can evaluate and later address the commission if they so choose to.

Commissioner Weter asked will the 24 hour hold effect prison population? Sheriff McNiel stated no, the statute provides warrant to process, and there's no investigation done, plus the prisoner can be released on bond, we don't have to hold 24 hrs based on what an officers says, its not our place to decide if guilty or not. We are responsible for prisoners well being if kept in jail. A report is in the process for all changes within the sheriff's department and will be provided in Mr. Weber's assessment.

7: The training schedules have been cancelled and will be rescheduled. Command staff schedules are made with the understanding that they are to respond to calls if officers are out on a call in progress. Commissioner Weter asked if the law enforcement staffing level compensation is adequate? Sheriff McNiel added that a sense of belonging is needed in the department, and the salaries should be raised for our officers, we have lost some last week and with the changes in progress we need to consider the reserve officers who dedicate their time and are not compensated for anything. We need to explore supplying them with equipment and vehicles that are in safe working order, which do need to be updated. Sheriff McNiel noted that he was in a vehicle today and experienced an unsafe issue about the car that needs to be fixed. A volunteer fleet coordinator is needed to maintain all aspects of the vehicle maintenance and we have someone who will provide the service on a pro bono basis, and Sheriff McNiel intends to bring him back. Current Dodge Chargers are not dependable vehicles, and Ford Flex is a better vehicle. The next sheriff will be informed regarding the matter, and improvement on the fleet vehicles will cut down the cost and be safe to drive. The process will take time and is an expense. Sheriff McNiel suggested capturing some of the money that's not been accounted for and possibly utilized that.

Commissioner Weter asked if the communication between law enforcement in the municipalities strained. Sheriff McNiel was of the opinion that more contact between County Law Enforcement and Municipal law Enforcement would help.

Commissioner Weter addressed in past we have had trouble with the paper trail on repairs made on the vehicles that are not itemized. Sheriff McNiel responded that we have addressed the matter that more detail from the officers are required when services are done, also another change made that information will need to be completed before any work is done on the vehicles, unless of course an emergency occurs.

8: Sheriff McNiel said for the record today he will be contacting the Missouri Senators to get rid of the MRAP in Ozark, he stated that we can use the money else were. We will share with Nixa's MRAP if need be. The savings will be a lot considering the cost of maintenance.

Ms. Dollarhite asked how much are we paying the consultant for services? Commissioner Weter stated \$4,500.00. Ms. Hart said all consultants services are estimated to be approximately \$35,000.00 total cost for 3 months service.

Ms. Judy Dollarhite thanked the Sheriff for his efforts, and asked about the matter regarding the uniform change. Sheriff McNiel said the uniforms will remain the same.

Sheriff McNeil also noted the vehicles dark window tint will be removed.

10: There are steps in the process to rebuild trust with the community, and boosting moral in the Sheriff's department is paramount. Mr. Rance Duffy, County 911 Director, said we need more staff process calls, reports, etc.. Sheriff McNiel responded there is a lack of structure in scheduling and staffing, and we need Corporals to assist on calls for service, we all will be responding to calls if needed. The accountability will be improved as well. Mr. Duffy said we need to be more effective in calls for help.

Commissioner Barnett asked Sheriff McNiel if he communicated with the Billings people. Sheriff McNiel replied that has already been scheduled for next week. Commissioner Childers stated we appreciate all of Sheriff McNiel's efforts in the sheriff's department. Sheriff McNiel stated we will have a much better atmosphere. Commissioner Weter concluded the meeting.
