### **Motion/Vote - 9:00 AM Kasha Driskill-Christian County Ambulance District**

Proposal - Annexation Proposal

The meeting was attended by Commission Secretary Cheryl Mitchell, Benefits/Deputy Clerk Mary Argiso, Hannah Smith Reporter with Ozark Headliner Newspaper and Ms. Kasha Driskill.

The Commission met with Kasha Driskill - Christian County Ambulance District to discuss the Annexation Proposal.

Ms. Driskill began stating that the Christian County Ambulance District would like to Annex portions of Christian County that are not in our ambulance district. There is one location in the panhandle and one that is in Stone County. One of those spots wants the CCAD to respond but they are not in our district. The CCAD would like to annex the whole Panhandle of Christian County. Clever seems receptive to this, Billings did not. They did not want to pay more taxes when they get free services from Republic. At this point we would just annex Clever. Commissioner Weter asked does Stone County have any input? I would feel better if we had something in writing from Clever. Ms. Driskill said I just started this process, and we would like to put it in the ballot in April 2016. Commissioner Barnett stated you should find a good response, and Billings should be involved. Ms. Driskill noted that Cox Health covers Republic, and they are willing to go to Stone County with us and talk to them. 911 transfers the calls to Cox Health and they dispatch the closest ambulance available. As for Clever & Billings, most ambulances come from Elsey which is 30 minutes away. Commissioner Weter said I would like to see Clever Fire & City administrators stating that they are in favor of this. We may need to have a public hearing. Ms. Driskill said a petition with 50 signatures in each area will need to be made. Commissioner Childers said we need something in writing from Billings stating their wish to be excluded. Commissioner Weter stated we need to communicate with Stone County, the Presiding Commissioner is Dennis Wood, or you can contact Mark Maples who is a Commissioner in that area to create a letter of permission. Ms. Driskill said Highlandville Fire is all for this, and they will help us get signatures. Their attorney thinks that if this passes we will be the largest Ambulance district in the state. She noted that their district is taxed based. Ms. Driskill commented that Christian County has nicer stations and ambulances which are very safe and very expensive as they are made like tanks. Commissioner Weter said my desire is that you carry out what we discussed today and return to us with an update. Ms. Driskill said that the plan is to have the signatures by the end of October.

The Commissioners thanked Ms. Driskill. Meeting was concluded.


