Discussion - Adoption of 2012 Building Codes

The meeting was attended by Commission Secretary Ashley Hannah, Bob Rubino, Kevin Larkin and Headliner reporter Amber Duran.

The Commission met to discuss the adoption of the 2012 Building Codes. Sue Ann Childers said the Building Board has approved these from their perspective. There will be three meetings before the final adoption. Bob Rubino wanted to speak in favor of approving the building codes as presented. Kevin Larkin asked for bullet points. Bob Rubino said they are all standardized across the nation. Sue Ann Childers said they are posted on the website for review. There are no changes. Kevin Larkin asked about the language. Sue Ann Childers said it was to make it more clear for Christian County. The next meeting will be November 19th at 9:00 and the final will be December 10th at 11:00 a.m. and after that there will be a vote to adopt the 2012 Building Codes.

Discussion - Insurance Discussion

The meeting was attended by Commission Secretary Ashley Hannah and Payroll Administrator Paula Brumfield.

The Commission met with Jeremy Billington-Billington Insurance for and Insurance discussion.

He represents Cape Girardeau County. They have savings of over a million dollars this year. They have no increase. This is a partially self funded plan with reinsurance. If you don't spend the money you can retain it here. If you spend the money with Cox you don't get the money back. With the Cox plan we have now there are 4 claims, two terminated and two still active. What sets Billington apart from the competitors is claims, claims are what is driving the cost of the health plan. He passed out plans. Under the current plan, all costs are fixed. What they are doing is taking the fixed cost and the claims cost are a secondary. Cox has a pharmacy benefit manager. They utilize express scripts. All of their groups have a rebate check every quarter. He would like to know who is getting the rebates with Cox on the pharmacies. Sue Ann Childers asked if there is a catch with generic or name brand. Jeremy said no, it is the same amount per drug depending on mail order or retail. They are utilizing Semetra. They are fully insuring every claim over \$30,000. The aggregate is a large \$100,000 claim the county pays \$30,000. The aggregate amount is \$543,132. We are guaranteed a total fixed cost of \$408,240. The increase is on the total fully insured fixed amount. The only increase you get with Billington is the pure claims, not the fees. He can give a fixed guarantee. He

took the old renewal and took the number Cox gave and came up with \$944,616. His expected cost is \$842,785. \$951,421 is the worst case scenario. He can guarantee the max cost is about \$10,000 higher on max. He hasn't had anyone go over expected cost. Sue Ann Childers asked what are his cost controls. He has a maxy plan. Anyone in the county can get it. It is excellent for people with Medicare. They pay Medicare rate plus 15% built into their plan. There are drug companies that give specialty drugs for free. They can put the person on the affordable care plan also after the year is up. If the employee doesn't qualify because they make too much money the county can purchase a plan for the employee under the affordable care plan. Billington offers ACP policy under the plan that allows them to purchase for the employee. Sue Ann Childers asked how are you going to get someone signed up if you go to the hospital and will require a lot of expenses. They have the maxy two, it is for people that have Medicaid. What Billington is doing is shifting cost. They have found other options. They look at other available carriers. The high claims that the county has had could have been better dealt with their plan. He can show the employees how to save money without costing the county money. He can do the same thing Cox does and offer the options. He can guarantee if you don't spend it with them, you get to keep it. If you get an increase with him it will only be on the insurance amount. Sue Ann Childers asked if he had anything to do with Work Comp. He doesn't. He presented a comparison between the Croley renewal and his rates. Sue Ann Childers asked who carries the ERISA plan. He said this is an ERISA plan. If he can save the county money and make the employee happy it is a win-win. Sue Ann Childers asked for a base plan of what is covered. He said they quoted what we have now. Billington will use Healthlink as PPO which is Mercy. They will go over line by line what will be covered if they are chosen. Bill Barnett asked how many counties he has, and Jeremy said he gave them a list last time he was here.


