Financials

The meeting was attended by Commission Secretary Ashley Hannah.

The County Commission discussed two financial issues.

Discussion was held about a resolution declaring intention to reimburse project expenditures in regards to a possible Justice Center Expansion. The Certificate of Participation would allow for up front money to be reimbursed by bond money.

County Commission previously had ordered a transfer of funds from LEST & COLE in the amount of \$75,000.00 to the Sheriff. The Treasurer was upset by the transfer of funds requested by the Sheriff.

Presiding Commissioner Weter said the Commission acted on what the Sheriff needed.

Discussion - Tornado Drill Debriefing

The meeting was attended by Commission Secretary Ashley Hannah, Robert Palmer, Barbara Stillings Circuit Clerk, Amelia Wigton, Linda Barger, and Phil Amtower.

Phil Amtower, EM Director & Assistant Linda Barger appeared before the Commission to present a synopsis of conclusions drawn from the recent tornado drill.

Phil said everything went well except for our phone numbers showing up on caller ID's without a message left, the

tornado sirens didn't go off in Ozark, Nixa's did, the All Page and the Swift 911 worked. The only source of contention is in the Judicial building, where the Sheriff doesn't want people in his offices.

Presiding Commissioner Weter said if it is a F5 tornado, allowances must be made.

Phil said the jail staff will be aware of the tornado warning and will open the door for anyone needing shelter but recommended Todd have a key to the Justice Center.

Barbara Stillings shared her concerns for a tornado on the day court is held and the increased number of citizens in the Justice Center.

Presiding Commissioner Weter asked if there are any other concerns or improvements needed other than the emergency lights that didn't work?

Linda Barger said the employees said there was lawn equipment that impeded traffic and loose boards with protruding nails that were stored in the basement.

Presiding Commissioner Weter said we need to follow up on the emergency lights that didn't work and remove all hazards in the basement such as: lawn equipment and loose boards with protruding nails.

Commissioner Childers asked if there will be another drill?

Phil said his next plan will be to give training by department to handle an active shooter.

Presiding Commissioner Weter asked how would you train to prepare for an active shooter?

Linda said it will be a slow process giving mini training sessions to each department.

Phil said at first it will be a generic procedure.

The County Commission met with Jared Younglove to discuss the Historic Courthouse Renovation Report.

Presiding Commissioner Weter said after reviewing the plans he would propose we choose Option 1.

Presiding Commissioner Weter asked Ralph Phillips to give a Security Analysis of the Historic Courthouse to utilize the existing Courtroom.

Lieutenant Phillips and Judge Johnson discussed the options of using the Courtroom for "Out of Custody Cases" that are non-criminal. Lieutenant Phillips recommended that the number of entrances to the Courthouse be reduced to one and all other doors would be used to exit only. Lieutenant Phillips said additional manpower is needed to secure the building. He wants to take a pro-active approach to security.

Jared said the future renovation of the Prosecutor's office will be approximately 1.1 million and estimated completion would be mid-2017.

Presiding Commissioner Weter said the proposed cost for all renovations: the Prosecutor's building - \$4.15 million, Historic Courthouse renovation - \$300,000, Judicial Center renovation \$1.1 million. The new property tax levy has an estimated amount of \$700,000.00-\$750,000.00 per year, will help pay for the renovation.

Presiding Commissioner Weter has concern for recent legislation proposed by Senator Wasson and Representative Hoskins, if not successful, the County could lose about \$300,000.00.

Presiding Commissioner Weter asked those present for any additional comments.

There were ideas exchanged such as Teleconferencing hearings to minimize security issues.

Karen Matthews was concerned where her office would be and the proposed office renovations for the elected officials that occupy the Historic Courthouse.

Jared briefly described the layout of the preliminary proposed plans.

Presiding Commissioner Weter said these are preliminary plans and not a forum; this is a time for public comment.

Presiding Commissioner Weter entertained a motion to approve the temporary Courtroom project and authorize Paragon to continue renovations.
