Miranda said that is including everything the boom, the mower, etc.

Presiding Commissioner Weter said I see there is a \$400.00 for hauling to and from Murphy Tractor.

Jason Parker said if you want us to do it we have to add transport to and from Murphy Tractor unless you are able to provide transport.

Presiding Commissioner Weter said also there is a \$1,200.00 charge for the removal of the old mower.

Miranda said I can only accept or deny what is on the order. If there are any changes we would need to do an amendment. We will make sure everything that they have submitted is what we ordered and make any amendments if needed.
