Bond - General Obligation Bond Order for Stonehollow NID

Attendees: Cheryl Mitchell, Judy Dollarhite, Robert Palmer, Hosea Bilyeu, Carl Yates and Amelia Wigton reporter of the Christian County Headliner News.

The County Commission reviewed and approved Order # 07-21-2016-2, submitted by Attorney Carl Yates, for the General Obligation Bonds for the Stonehollow NID. Mr. Yates said the petition was signed by 66% percent of the owners located in the Stonehollow Neighborhood District. The funds were used to chip and seal the streets within the neighborhood. Mr. Yates said prior to chip and seal, the road bed needed work done. Mr. Yates said the order states the bonds will be issued for the project from Ozark Bank. Mr. Yates said Ozark Bank was the only bid submitted from any financial institution. Mr. Yates said the original estimate for this project was \$ 360,000.00. The project came in at \$ 318,000.00. There is a reserve of \$ 34,823.47, in the debt service fund and the grand total to be bonded is \$ 348,234.74. Mr. Yates said his fee is \$ 8,400.00, in total.

Mr. Yates said the Commission will need to approve the order. Mr. Yates said the property owners will be assessed a sum of \$ 13,929.39, and will have 30 days after the

letters are mailed to pay off the total amount without any interest charges. Mr. Yates said the interest is 2.99%. Mr. Yates said a transcript must be sent to the State Auditor to certify the bonds are in accordance with the constitution. Mr. Yates said August 15th, 2016, is the date of the financial closing on the sale of the bonds. Mr. Yates said the Missouri State Auditor has to approve the bonds before they can be issued. The bank will then know what they owe and there will be the 30 day window for a total amount to be paid and 15 days of interest.

Mr. Yates said Selmore Special Road District has agreed to accept the road and maintain it and Common 2 will have a quarter mile or less to maintain which Selmore Special Road District has agreed to also take care of this. Ozark Bank in the agreement has agreed to buy all the bonds as an investment in accordance with the Missouri Security Act.

The amount of the bonds for the Stonehollow NID will be reflected as a liability in the 2017 budget. Mr. Yates will bring closing documents after receiving approval of the Missouri State Auditors.

Report - Quarterly Report

The County Commission met with Linda Barger and Phil Amtower with the Christian County Emergency Management for the quarterly report.

Phil Amtower said the Dept. Of Homeland Security oversight committee provides grant money throughout the region. Mr. Amtower said when the Joplin tornado destroyed the hospital, the Dept. Of Homeland Security purchased a large trailer that contains a shower and a laundry that was used for the temporary hospital. The cost of this trailer was approximately \$ 100,000.00, and they want to get rid of it. Mr. Amtower said the Red Cross approached Convoy of Hope to give it to them. Mr. Amtower said he wants it and doesn't want it to go to Convoy of Hope because we don't share the same mission. Mr. Amtower said this is a big piece of equipment and he wanted to know if the County Commissioners had any interest and would consider acquiring it to be shared in the region. Mr. Amtower said the trailer is free but we would incur the cost of insurance and

repairs. Mr. Amtower said if you are interested we would present a letter to them.

Commissioner Weter said the problem is storage and we have so much and it would have to be stored in a secure area.

Phil Amtower said he will be attending a CERT conference in Washington D.C. at no expense to the county and the National CERT conference in California. The expenses of the Washington D.C. trip will be covered by Homeland Security grant.

Mr. Amtower said he has begun working on next year's budget. Mr. Amtower said he will be receiving \$ 46,842.26 from the Emergency Management Performance Grant. Mr. Amtower said the state pays half of his wages and Linda Barger's wages. The state also pays half of their benefits and office expenses. Mr. Amtower said he is getting more requests for technical support from the fire departments for a map of their district with a street index file in each district.

Re: Proposal for Christian County, Missouri

Southwest Missouri Forensics will provide forensic autopsy services for Christian County as follows:

1. Keith N. Norton, MD (a Board Certified Forensic Pathologist) will complete autopsies on deaths (violent, suspicious, accidental, and unexpected natural) as needed.
2. The staff of Southwest Missouri Forensics will work cooperatively and closely with the Christian County Coroner, all law enforcement agencies and the Christian County Prosecutor's Office.
3. Payment for forensic autopsy services will be as follows:
  - Autopsy - \$1350.00
  - Toxicology - \$250.00 minimum. Total fee is determined by the number of drug/alcohol confirmations per autopsy.
  - X-ray - \$250.00
  - External examination by Dr. Norton - \$500.00
  - Decomposed body – additional \$300.00
4. This proposed agreement would run consecutively for a twelve-month period. It will be renewed on an annual basis. This proposed contract will be terminable at will at the option of either party upon their furnishing a ninety-day written notice to the other party.
5. It is understood that the Christian County Coroner, Amanda Yoder Armitage, will not participate or receive any fee from Southwest Missouri Forensics for autopsy services they may render for Christian County decedents. If Amanda Armitage is present at an autopsy, it will be in her capacity as the Christian County Coroner only.
