Report - 3079: Quarterly Report - Public Administrator Ken Davis

The County Commission met with Public Administrator Ken Davis for the quarterly report.

Ken Davis said over the last quarter he gained five more estates. Mr. Davis said two of his clients died. Mr. Davis said he has being dealing with a 8 year law suit that just ended. Mr. Davis said he had three cases where the court appointed his office to oversee the work. Unfortunately, there are no funds to pay expenses and if the estate is opened we have to hire an attorney when there is nothing in the budget to cover the costs. Mr. Davis said he has two older attorneys that have assisted him to chase assets to get money for the hospitals against Medicaid. Mr. Davis said when there is a private case, legal costs are incurred and he has a problem with getting attorneys to handle those cases.

Mr. Davis said new legislation has been presented to update some antiquated probate laws. Mr. Davis said the new legislation would require a full time employee for every 50 cases, not including the Public Administrator. Mr. Davis said in addition, he would have to have on site visits for all 550 clients every month. Mr. Davis said that means more funding and deputies to split the case load. Mr. Davis said he would suggest having Susan Pathkiller be deputized to handle the increased work load.

The County Commission met with County Recorder of Deeds Kelly Hall for the quarterly report.

County Recorder of Deeds Kelly Hall presented the 2016 July quarterly report and compared it to the 2015 quarterly report for her office. Recorder Hall said the County Commission has the ability to vote to raise the marriage license fee an additional of \$5.00, from \$46.00 to \$51.00 to be given to the domestic violence shelter. Recorder Hall said this would raise the current amount donated to the shelter from \$900.00 to \$1,600.00. Recorder Hall said 34 federal tax liens were submitted last year and 27 this year. Recorder Hall said 239 state tax liens were issued last year and 80 so far this year. Recorder Kelly Hall said the tax liens are more work to process and the pay \$1.50 to \$1.30 per tax lien.

Eastern Commissioner Childers asked are you anticipating needing more capital if the computers go down?

Recorder Hall said not at this time.
