The County Commission met with Miranda Beadles to approve a grant notice and agreement award for the Keltner Road Grant from the U.S.D.A.

Miranda Beadles said the total projected cost of the Keltner Road project was \$ 487,000 but was reduced to \$ 250,000. Miranda Beadles said the county's portion is \$ 62,500. Ms. Beadles said the grant forms need to be signed to be awarded the funds from the USDA. Miranda Beadles said by signing the grant document the USDA is locked in but the county is not locked in. Miranda Beadles said the USDA will reimburse the county 75% of the cost. Miranda Beadles said the road department has done a lot of work. Miranda Beadles said after the grant documents have been signed then the project can be bid. Miranda Beadles said the county is not locked until ground is broken for the project.
