Bid Decision - Bid Decision-Assessor Floor Covering Attendees: Jim Billedo, Miranda Beadles, Hosea Bilyeu, Danny Gray

The Commissioners met with Danny Gray, Christian County Assessor, for a bid decision on floor covering.

Presiding Commissioner Ray Weter said that the Assessor is going to cover the cost of the floor covering and we put it out to bid.

Danny Gray said that we had two bids, from Midwest Rug and Stoneridge Carpets, Inc. Stoneridge's bid was initially less expensive, and even after modification it is still the least expensive of the two bids. The bid is for \$12,409.74. Midwest Rug's bid was for \$14,451.00.

Danny Gray said that he would recommend accepting the bid from Stoneridge Carpets, Inc.

Ms. Beadles said that her department had submitted an RFQ for an Engineering Consultant (GEO Tech and Survey). She said that her department wanted to have multiple firms on contract for different upcoming projects, which would also allow for competitive pricing. She said she left the RFQ general so that the engineers could be utilized in different departments. She didn't send the RFQ directly to anyone, but she did call various firms and made them aware of it. She will score the RFQ's and come back with a recommendation. She doesn't pick consultants based on rates, they are rated by qualifications and then they negotiate later.

The first RFQ opened was from Palmerton & Parrish, Inc. They submitted four copies and a CD for the RFQ. The second RFQ opened was from Horner Shifrin, which also submitted four copies. The RFQ's are filed with the Christian County Clerk's office. Presiding Commissioner Ray Weter entertained a motion to meet with Ms. Beadles on November 14, 2016 to hear her recommendation.

The Christian County Commission met with Josh Warren from Paragon Architecture regarding the construction renovation update. Mr. Warren presented an agenda for the meeting. Presiding Commissioner Ray Weter asked if ADA Compliance was included in the original bid. Mr. Warren said that he'd have to confirm that with Brad Erwin. Western Commissioner Bill Barnett asked if they are running on schedule. Mr. Warren answered that when he checked two weeks ago they were on track for being finished by November 30, 2016. There was discussion about an overhead air conditioning unit, and Presiding Commissioner Ray Weter said that they will check on costs and get back with Mr. Warren later. Presiding Commissioner Ray Weter reminded Mr. Warren that the Commission can't consider the change orders until they are presented. Ms. Childress asked Mr. Warren what the time frame is for remodeling the courtroom in December. She said that she's not been able to schedule courtroom meetings because of the uncertainty of remodeling completion. Mr. Warren said that he doesn't know yet, but once he gets the approval or denial he can inform her. Presiding Commissioner Ray Weter entertained a motion to send the documents regarding change orders to the Auditor for her review and approval.
