Bid Opening - Bid Opening-Poll Pads

The Commissioners met with presenter Kay Brown for a bid opening for poll pads. Ms. Brown said that the Secretary of State has approved grant funds to purchase additional poll pads, and she'll need to spend it before December 31, 2016, or else she will lose the grant funds. Kay Brown said that the poll pads are efficient in many ways, and they save a lot of time during elections. Presiding Commissioner Ray Weter asked if the grant will pay the total amount of \$16,500.00 quoted from KNOWiNK LLC. Ms. Brown answered that the grant will pay \$13,000, and the 5% fund will be utilized to pay the remaining balance. Ms. Brown said she would like to look over the details of the bid and make a final decision on Thursday, December 1, 2016. Presiding Commissioner Ray Weter entertained a motion to postpone a decision on the bid for poll pads until Thursday, December 1, 2016.

Presiding Commissioner Ray Weter said that this agenda item is a discussion regarding the affirmative votes on proceeding with construction of the 32,000 square foot annex to the justice center. Presiding Commissioner Weter said that we have a pending request for a vote change by Eastern Commissioner Sue Ann Childers, and this is allowable under Robert's Rules of Order with unanimous consent. Presiding Commissioner Ray Weter entertained a motion to allow Eastern Commissioner Sue Ann Childers to change her Yes/Aye vote. Eastern Commissioner Sue Ann Childers then presented a letter in regards to her change in vote. Presiding Commissioner Ray Weter noted that the question of building a jail can only be addressed if the citizens agree to a Capital Improvement Tax. Presiding Commissioner Ray Weter said to let the record show that the Commissioners unanimously approved the motion to allow Eastern Commissioner Sue Ann Childers to change her vote from an affirmative vote to a "no" vote on the question of construction of the 32,000 square foot building, originally voted on November 17, 2016.
