Monthly Update - MoDot Monthly Update

The Commissioners met with presenter Beth Schaller to receive the monthly MoDOT update. Ms. Schaller reviewed ongoing projects, including construction at the intersection of 14 and 160, the interchange at highways NN and J, and the construction at highway 65 and Evans Road. She then talked about upcoming projects in Springfield, including rebuilding concrete pavement on highway 65 in the Springfield area. Ms. Schaller then spoke about upcoming lane expansions and intersection improvements in Nixa and Ozark, and how revenue is up partly due to the fact that the economy is improving and gasoline is less expensive. Ms. Schaller mentioned that MoDOT will soon be reviewing their Transportation Alternatives Program grant fund applications, and will be letting the applicants know towards the first of the year who will be chosen. Presiding Commissioner Ray Weter entertained a motion to enter the verbal report presented by Beth Schaller on behalf of MoDOT into the Christian County minutes.


