The Commissioners met with presenter Andrea Swope with CC Links. Ms. Swope said that CC Links has partnered with Oats to make County-wide transportation available to anyone in Christian County. She said that since they've opened the program up to anyone in Christian County (and not just the individuals they currently serve) their costs are cut in half. The costs will be \$2.00 per ride, and the individuals utilizing the service have the option of being transported to the south side of Springfield so that they can use the city bus there. Ms. Swope said they have limited hours right now, but they anticipate expanding it if they have more people using the service. She noted that they are working on marketing the service utilizing social media and other resources, and Presiding Commissioner Ray Weter said that he would like to put the information on the County website if possible. Ms. Swope presented a flyer with more information to the Commissioners. Presiding Commissioner Ray Weter entertained a motion to enter the information Ms. Swope provided regarding the institute of a County-wide transportation system in Christian County into the record.

Monthly Update - Monthly Update - November

Auditor Lacey Hart presented her monthly report for November to the Commissioners, and then read from her report. Presiding Commissioner Ray Weter asked what will

happen under the new Conceal and Carry legislation if there's still money existing in that fund. Ms. Hart answered that there will still be incoming revenue because there will be circumstances where people will need to obtain a Conceal and Carry permit. Eastern Commissioner Sue Ann Childers said to Ms. Hart that they were supposed to receive a budget from her by November 15, 2016. Ms. Hart said that the reasons why she didn't get it done are because of other departments not sending her the information she wanted, not getting information on Workman's Comp and Insurance until November, training on new software, and not getting information she requested from the Commission regarding rate increases. Eastern Commissioner Sue Ann Childers asked Ms. Hart for clarification on what should be done in regards to salary for employees starting employment in January of 2017. Ms. Hart said that a salary sheet should be turned in for those employees, and then if the budget doesn't get approved for that amount later it will have to be adjusted. Ms. Hart left the meeting abruptly. Eastern Commissioner Sue Ann Childers moved to accept Ms. Hart's monthly report for November into the minutes.
