The Commissioners met with presenter Phil Amtower of Christian County Emergency Management to discuss bid renewal for Swift911. Mr. Amtower said that since we don't have a budget yet he wants to make sure that our mass notification system gets renewed. The system has to be payed for by February 1, 2017. Presiding Commissioner Ray Weter told Mr. Amtower that if the renewal is in his budget request, then it's ok. Mr. Amtower noted that this system was re-bid last year and it has an automatic renewal, so it's re-bid every three years. Presiding Commissioner Ray Weter entertained a motion to authorize the renewal of Swift911 with SwiftReach Networks in the amount of \$9,995.00.


