Bid Decision - Bid Renewal-Sheriff Deputy Uniforms

The Commission met with presenters Julia Maples and Captain Lofton to discuss a bid renewal for Sheriff's deputy uniforms. Ms. Maples thanked the Commission for meeting with them, and said that the Sheriff's office put out uniform bids last year with the option to renew for two consecutive years if they so choose. Captain Lofton said that it seems to work well having both Southern Uniform & Equipment and Franks Uniforms as providers, because if they can't get items from one, they can get them from the other. Ms. Maples asked that the Commission approve renewing the bid with both companies

for one more year. There was discussion about the way a requisition was filled out for uniform items, and Ms. Maples said that the requisition was detailed in order to expedite acquiring a uniform for a new employee. She also mentioned that the items listed on the requisition are standard issue uniform pieces. Captain Lofton noted that there are extra uniform items in their locker area, and they will recycle those items when they can instead of buying new, but there are occasions when it is necessary to buy a new uniform. Western Commissioner Bilyeu moved to extend the contract for one year with Southern Uniform & Equipment based in Carthage, Missouri, and Franks Uniforms, based in Springfield, Missouri, as it relates to the Sheriff's deputy uniforms.


