Discussion - Goodall Adjudication Update

Attendees: Prosecutor John Young

Late Arrival: Hannah Smith with the Christian County Headliner

The Commissioners met with presenter John Young of the Christian County Prosecutor's Office to discuss an adjudication update on the Goodall case. He gave a background on the case and presented the Commission with a copy of her probation order and charges. Mr. Young asked the Commission if they would like to file a claim for restitution on behalf of the County. Western Commissioner Bilyeu asked if the defendant would be required to pay full price for the television and iPads that were taken. Mr. Young answered that the law states the fair market value is the difference between the time the items were purchased and the time they were recovered, and that the items have to be depreciated. Western Commissioner Bilyeu said that he would lean toward restitution at the highest amount permitted by law. Presiding Commissioner Weter said he believes we're owed what we spent on the service plans during the time when the iPads weren't available for use. Presiding Commissioner Weter said that it sounds like trying to pursue restitution for the costs of the iPads and TV is futile because you can't come up with a specific number, but the data plans are hard numbers. Mr. Young said he'd be happy to put together the numbers and present it. Presiding Commissioner Weter said one of the things the Commission hears about a lot is their inability to collect the court judgment from the former Sheriff. He said we can't exercise anything to make that happen because it's a federal court issue, and he wants to make sure we get restitution on this issue. Western Commissioner Bilyeu moved to pursue restitution for the cost of service plans on the two iPads in question for the period of time that the County was denied use of said iPads. Mr. Young mentioned that there is no official written county policy on the use of county property, and said if the Commission needs help with that in the future to let him know.


