Bid Decision - Bid Decision-Thermal Patchbox

The Commissioners met with presenter Miranda Beadles regarding a bid decision for a thermal patch box. Ms. Beadles said last week we had a bid opening for a patch box to be utilized in Common One. She's reviewed the submittal and everything seems to be in order. Ms. Beadles said the vendor has met or exceeded the minimum specifications she submitted including a one-year warranty and eight hours of training for the road crew when H.D. Industries, Inc. delivers the patch box. Ms. Beadles recommends the award be given to H.D. Industries, Inc. For the thermal patch box. Presiding Commissioner Weter said we had a thorough presentation and discussion about this issue last week, and entertained a motion to approve the recommendation of Ms. Beadles, Christian County Highway Engineer, for the purchase of a thermal patch box as bid by H.D. Bid Opening - Bid Opening-County Office Supplies Attendee: Director of Purchasing Leo Snelling The Commission met with presenter Leo Snelling for a bid opening for office supplies. Mr. Snelling opened a single bid which was submitted by Quill and said he will take the next few days to review and compare the bid to the one received last year, and then will come back with a recommendation. Ms. Young said that she emailed many vendors, and sent the bid solicitation to everyone on the suggested bid list. There was discussion on the ability to purchase products locally if they are at a local price, as well as the utilization of secondary vendors. Presiding Commissioner Weter asked Ms. Young to consult with County Counselor John Housley to see what their options are. Presiding Commissioner Weter entertained a motion to have Mr. Snelling review this bid and come back with a recommendation on Thursday, March 16, 2017, and in the meantime make an inquiry to Counselor Housley regarding having a secondary source locally, depending on price.

The Commission met with presenters from the Sheriff's department (standing in proxy for Sheriff Brad Cole) to discuss security. Lieutenant Duryea said they've expanded the campus security division, therefore, they do not have enough keys for the campus security staff. He said they will need thirteen sets of keys total. Presiding Commissioner Weter asked Lieutenant Duryea if any of the current staff has keys in their possession now. Lieutenant Duryea answered no, his bailiffs have incomplete sets. He said there was an incident where a stairwell door was found open and no one had a key to lock it so a janitor had to be contacted to lock the door. Lieutenant Duryea said he'd like to serialize keys. Eastern Commissioner Phillips said there's no key control, and there was discussion about proxy cards. Ms. Young said the security staff will need to compile a list of keys they will need for both the judicial center and the historical courthouse. Eastern Commissioner Phillips recommended identifying who has keys and who doesn't. Lieutenant Duryea suggested securing the janitor's key ring and making a copy of it, and said at this point it may be prudent to change some of the locks. Presiding Commissioner Weter entertained a motion to have the presenters inventory what is needed and get back with the Commission.
