The Commissioners met with John Young, Christian County Assistant Prosecutor, regarding a discussion about restitution in the Goodall case. Mr. Young said in his previous discussion with the Commissioners he asked them to gather information regarding a demand for restitution. Mr. Snelling sent Mr. Young an e-mail outlining a proposed claim for restitution, which includes service contracts for two iPads for a total

of \$1,919.52. Mr. Young said he will submit the restitution claim in that amount, and if the opposition disputes it there will be a hearing. Presiding Commissioner Weter entertained a motion to proceed with the restitution effort based on the recommendation by Mr. Snelling.
