
The County Commission met with presenters Sheriff Brad Cole and Captain Koch to discuss the DSSSF Grant. Sheriff Cole said the grant provides supplemental pay of approximately \$100.00 per month to deputies that are paid less than the base pay set forth in the grant. The grant application was prepared by Lieutenant Smith and requires the signature of the County Commission for approval. Sheriff Cole said the grant provides an additional \$12,000.00-13,000.00 in revenue for eligible deputies, has a six-year time line, and the funding is supplied by the fees for civil process that are served to the public. Western Commissioner Bilyeu asked if the grant would cease if the deputies were to receive higher wages. Sheriff Cole answered yes. Auditor Hart said the grant

needs one correction regarding the date, and should have September 28, 2016 as the completion of the audit. Western Commissioner Bilyeu suggested that in the future the Auditor send an email to all offices when the audit is complete. Ms. Hart said she didn't find that necessary as it is available on the website. Western Commissioner Bilyeu said he will make a note to send out an email to all of the offices once the audit is complete, and then moved to approve the DSSSF grant application.
