The Commissioners met with presenter Miranda Beadles, Highway Administrator, regarding a MoDOT bid. Ms. Beadles said she would like to use MoDOT bid request no. 3-140214RJ to purchase new dump trucks. The guotes were as follows:

For Common One: \$129,832.00 for 4700 set-back front axle chassis, plus \$33,960.00 assembly, parts, and labor.

For Common Two: \$105,356.00 for 4700 set-back front axle chassis, plus \$33,960.00 assembly, parts, and labor.

Ms. Beadles said trade-in values are included, and recommended the Commission accept the MoDOT bid with Midway Sterling Truck Center Western Star for the purchase of three tandem axle trucks which have been budgeted for this year. Presiding Commissioner Weter entertained a motion to accept the bid for the three specified vehicles and to proceed with the acquisition of said vehicles.

Presiding Commissioner Weter said this emergency session has been called to address delays in the processing of requisitions, and said there was a four-step process previously adopted. Ms. Maples said on a department level they are having a challenge as they are a public safety organization, and they haven't received a requisition all week. Ms. Hart said the process is delayed because of paper documents going through the regular process and having to be entered into the accounting system. Eastern Commissioner Phillips suggested that individuals involved in the purchasing process be notified via email when it's their turn to do their part in the purchasing process in order to avoid a breakdown in communication. Presiding Commissioner Weter noted that they've anticipated some of these problems because various departments did not have a chart of accounts. Ms. Fite said the Prosecutor's office is still only using paper requisitions because they don't have the Tyler program on their computers. She said we have a late fee, and they've had to request that the credit card company remove late fees over the last two and a half years. Ms. Fite asked that a cutoff time be set so her department knows they're timely. Ms. Hart suggested submitting a request on a requisition so it's ready when the credit card bill arrives. Ms. Fite said it would not be efficient to create separate requisitions for one bill, and could create more issues later. Ms. Beadles said her department is still using only paper requisitions because they haven't received login information for Tyler, and she hasn't received a signed requisition back in two weeks or more. She said she's received numerous calls about late fees. Eastern Commissioner Phillips asked for a show of hands from departments that have incurred late fees. Six department heads raised their hands. Eastern Commissioner Phillips asked Ms. Hart if she knew we were going to go live May 1st, why didn't every office have access. Ms. Hart answered that months ago she requested PC Net to install Tyler on computers for everyone, and she thought it had been. Mr. Snelling said there are about 119 purchase orders or requisitions unaccounted for. He said many of the purchase orders have been created, but nothing has been processed in Accounts Payable because Ms. Hart input purchase orders and he didn't get them back. Mr. Snelling said the last purchase order he received back was dated May 1st, and that's what's holding Accounts Payable up. He said he's asked Ms. Hart every day for the paperwork, and she says she's not done with it. Presiding Commissioner Weter asked where the documents are at. Ms. Hart said it was returned to the Commission office, and she thinks she put them on the desk or gave them to the secretary. Western

Commissioner Bilyeu said we are hearing that vendors that no longer want to do business with us because it's too hard to get their money. Ms. Maples said this is the fourth meeting where I've voiced concerns about not having access. Eastern Commissioner Phillips said we will facilitate that to get you what you need. Presiding Commissioner Weter said we are now in recess.
