The Commission met for a County Operations Meeting, with the subject being the Tyler software update. Presiding Commissioner Weter introduced the new I.T. Specialist, Cole Ewing to the members of the audience. Mr. Ewing is currently working on getting everyone up to speed on the requisition and purchasing processes. There was discussion about how the program was allowing someone at a higher approval level to approve purchases at all levels, causing the system to cut the Auditor out of the purchasing process. The approval path has since been modified to assure this problem is corrected. Western Commissioner Bilyeu moved to amend the requisition approval path. The approval path will commence as follows:

- 1. The initiation of the requisition will come from the Department Head or appointee.
- 2. The requisition will then go to the Auditor, who will confirm that there's money available in the budget.

3. If the requisition is approved it will be returned to the Purchasing Agent, who will then create a purchase order. The Department Head or appointee will be able to see that their purchase order has been approved, and the order will be placed.
