Closed session was terminated by means of roll call vote, and the Christian County Commission is now back in regular session.

The Commission met for a County Operations meeting, with discussion regarding the requisition approval path and assessment in regards to unapproved requisitions. There

was discussion about the progress being made, and Western Commissioner Bilyeu said it is appropriate for anyone to communicate with Mr. Ewing regarding system administration issues because he implements that. Mr. Ewing's willingness to help was complimented by several office holders and department heads. Office holders and department heads expressed concern about requisitions being held up and vendors being payed late. Ms. Maples asked that some kind of cheat sheet be distributed by the Auditor that would outline what she wants in various fields in the Tyler System, in order to maintain consistency and accountability.

Sheriff Brad Cole expressed concern about consistency, and said a written set of guidelines from the Auditor with definitions for categories would be very helpful. Sheriff Cole said there are a lot of things that are time sensitive and important for their office to ensure the public's safety, and they can't wait 5 to 20 days for the current approval process.

Auditor Hart suggested that users utilize their training materials and set up a requisition template.

Clerk Kay Brown said that she would like to have clarification on where invoices are, because Ms. Ryan cannot pay a bill without the associated invoice. Western Commissioner Bilyeu said they are working towards that, and Mr. Marmouget had suggested a standardized timing process.

Assessor Gray mentioned that he's had a lot of late charges, and asked that they figure out a way to process through the requisitions faster.

Mr. Ewing presented the audience with a document that outlines the paths that requisitions and purchase orders follow from start to finish currently.
