Discussion - 06-22-17-5 Bid Opening-Water Heaters Building & Maintenance

The Commission met with presenter Leo Snelling for a bid opening for water heaters. There were no bids received, and Mr. Snelling said we will re-advertise. Mr. Teague said currently the kitchen jail is utilizing two on-demand water heaters, which are working at maximum capacity and barely doing what they're needing them to do. Mr. Teague said the heaters are not built to run 24 hours per day, and they are pushing them past their design limits at this point.

Discussion - 06-22-17-6 IGA-Parking Agreement

The Commission met with presenter Brad Erwin of Paragon Architecture regarding a Parking Intergovernmental Agreement. Mr. Erwin presented the Commission with a projected timeline for the Judicial Center Annex, and said there is a scheduled bid opening for July 13, 2017, for the steel, concrete, and site utilities. It was noted that the last known project cost was 10.4 million, however, there weren't funds set up for the expansion of parking lots in that calculation. Mr. Erwin presented the Commission with a copy of the preliminary IGA between Christian County and the City of Ozark, and proposed amending items 2.B and 2.C. Mr. Erwin proposed changing section 2.C to capture the spirit of the language without pinning down a specific number. He then proposed altering section 2.B to reflect Paragon's recommendation of committing to 42 new off-street parking spaces, which will include 10 secure parking spots which are not available for public use. Mr. Erwin suggested that the Commission allow him to present this information with the adjustments recommended to the Planning and Zoning Commission on Monday evening so they can provide their approval, and then after that finalize this and present it to the City Council as part of the right-of-way vacating process. Western Commissioner Bilyeu asked how much the cost will be for the additional 42 parking spaces. Mr. Erwin said about \$200,000.00, making the estimated project cost 10.6 million. Eastern Commissioner Phillips entertained a motion to make amendments to the IGA as presented by Mr. Brad Erwin. Western Commissioner Bilyeu moved to authorize Mr. Brad Erwin to make the changes that were recommended to the IGA in order to present to the appropriate city gatherings as this process moves forward, and said the IGA will still need approval from the Commission before it is officially adopted.
