Discussion - 07-14-17-2 Emergency Meeting

An emergency meeting was called regarding vendor Card Services. It was noted that Sheriff Cole has statutory training this weekend, and Card Services has frozen the credit card account unless they receive the total payment due of \$3,352.54 by 5:00 p.m. today, since the account has been habitually delinquent. Norma Ryan, the Accounts Payable Clerk, said that some of the payment due is currently in the mail, and the remainder is

on a requisition with a change order that hasn't yet been approved by the Auditor. Presiding Commissioner Weter quoted from RsMO 50.160.2, which states: The County Commission may order the payment out of the county treasury any sum of money found to be due by the county on such accounts. Presiding Commissioner Weter asked if a check could be sent electronically by 5:00 p.m. to the vendor. Treasurer Matthews said we don't pay electronically because she prefers not to do so. Sheriff Cole noted that he would need around \$400.00 for this weekend to cover the cost of lodging during training. Discussion was held, and it was decided that a check would be cut directly to the hotel to cover lodging expenses. Western Commissioner Bilyeu said that as soon as we can place it on our agenda he wants to look at all of the requisitions and purchase orders related to the Sheriff's department that are not being processed in a timely fashion and address them. Western Commissioner Bilyeu moved that because of the locking down of a credit card related to the Sheriff's department and the inability to use said credit card, that we move quickly to provide him with a check for the hotel, and provide sufficient funds to the credit card in order to pay the balance and be able to use it again.




