The Commission met with presenter Michelle Bock regarding financing for the Justice Center annex. There was discussion about the finance schedule for issuing of debt, and the determination of the amount the County will borrow for the project. There was discussion about the City of Ozark asking the County to add parking spaces, which would cost approximately an additional \$250,000.00, generating a total amount of 8.45 million to be borrowed. There was then discussion between Ms. Bock and Auditor Hart regarding the continuing disclosure obligations, specifically the timing. An agreement was made to change the timing of the audit and operating information provided from 180 days to 210 days, with the understanding of an internal goal of 180 days. Ms. Bock said she anticipates the first payment for the project will be around March 1, 2018, and the payments will be made twice per year. Presiding Commissioner Weter said to let the record show we had a conference call with Michelle Bock of Piper Jaffray to discuss the mechanics of the bonding process.
