The Commission met with presenter Judge Laura Johnson regarding a discussion and proposal for the position of Treatment Court Administrator. Judge Johnson presented a formal written proposal to the Commission for the approval of the creation of the position, with the desire to see the position continue after this fiscal year ends. Judge Johnson gave the details of the position, and said the proposed salary would be \$24,000.00 annually, plus reimbursement for mileage at the County rate. Judge Johnson said she will fund the position for the rest of this year from her budget, along with funds awarded to the position from the Law Enforcement Restitution Fund board, and this position will be on a contract basis. Discussion was held, and Judge Johnson said she will offer this position to the prospect who has been identified as a good match for this position, will send the contract to County Counselor Housley, and will also speak to our Interim Auditor Keith Robinette about adding a line item in the budget for this position. Western Commissioner Bilyeu moved to table the matter of the Treatment Court Administrator position proposal until August 21, 2017 at the regular Commission meeting.


