The Commission met for a discussion regarding a letter to the governor, in reference to the appointed interim auditor. Discussion was held in regards to the Commission making a recommendation to the governor on who he should appoint to the position of auditor for Christian County. Presiding Commissioner Weter advocated for the governor to appoint Keith Robinette who is now serving as our interim auditor to be our appointed auditor. Western Commissioner Bilyeu also advocated for Keith Robinette. Eastern Commissioner Phillips said while he has no doubt of Mr. Robinette's capabilities, he is concerned about a conflict of interest with the special road districts. He suggested that the Commission have a public announcement of vacancy. Discussion was held, and Eastern Commissioner Phillips noted that we still have a deputy auditor position that is empty, and it would be in our best interest to fill that position. Western Commissioner Bilyeu noted that the Commission shared appointment of the interim auditor with Judge Laura Johnson. Western Commissioner Bilyeu moved to send the letter to our governor with the signatures of the Commissioners that are in agreement indicating their support for Keith Robinette remaining as the interim auditor.
