The Commission met with presenter Todd Wiesehan, Resource Management Director, in regards to Rezoning Hearing Case #2017-0244 (Turner Building and Development). The applicant requested a zoning change to Planned Unit Development (PUD) for the location of State Highway NN at Southernview Road in Ozark. Discussion was held in regards to the density of the planned development (Approximately two homes per acre) with a centralized water waste system, and how there is a need to address the grant of a waiver by the County Commission under section 393.847 RsMO for the placement of a waste water treatment facility within this unincorporated area of Christian County. Discussion was held in regards to Ozarks Clean Water Company sending monthly samples to the Department of Natural Resources, the proposed wastewater system, septic tanks, water storage tanks, wells, and loading rates. Mr. Cox asked the Commission to inquire of MoDOT to extend the 45 mph speed limit from Orschelns to County Line Road in Ozark, and expressed his concern about turn lanes in that area. Ms. Beadles suggested a two step process to address the issue, first to request enforcement, and secondly to request a speed study. Ms. Beadles agreed to initiate the request for a speed study. County Counselor Housley then spoke about the conditions presented and asked questions, and Mr. Casaletto answered Mr. Housley's inquiries. Discussion was held, and Eastern Commissioner Phillips moved to approve the change in zoning

classification from A-1 to PUD as outlined by Resource Management Director Todd Wiesehan and to approve the treatment water facility contingent upon the requirements noted by Planning and Zoning and also upon review of County Counselor Housley.
