Discussion - 04-2-18-3 State Employee Reimbursement Issue

The Commission met in regards to a discussion about state employee reimbursement, as it was noted by Auditor Amy Dent that since the "Same Day Travel" portion of the Employee Handbook had changed, we needed to update the reimbursement rate for state employees. It was noted that the County reimburses at a higher level than the state does. Auditor Dent then reported that the County needs to reevaluate its expenditures, because currently revenues are down and expenditures are up. There was then discussion regarding the future operating expenses of the new Circuit Court Building. Auditor Dent reported that in 2017 over \$800.00 was reimbursed to the courts just in mileage alone, and 31.6% of the mileage and training line in General Revenue was allotted to the courts. It was noted that there are no statutes that specifically relate to the reimbursement of state consolidated court employees, and the reimbursement of said employees are up to the discretion of the County Commission. Western Commissioner Bilyeu stated that his desire is to continue to reimburse the courts at the rates that we have been until someone can produce a clear statute that says that the Commission doesn't have to, and he doesn't want the construction of the new Circuit Court Building to negatively impact the County's employees. Eastern Commissioner Phillips mentioned that he's never lost money on mileage and per diem. Commissioner Phillips then voiced his concern over future operating expenses for the new Circuit Court Building. There was further discussion, and Eastern Commissioner Phillips moved to take the recommendation of Auditor Amy Dent, and adhere to the statutes as outlined for mileage and per diem, for reimbursement at the state rate, as applicable to state employees.
