The Commission met with presenters Phil Amtower, Emergency Management Director, and EMA Assistant Cheryl Mitchell, for a verbal quarterly report. Mr. Amtower gave an update on CERT classes, mentioned he spoke at an EMA conference recently, and noted that the EMA Department will be attending the National CERT conference in August, which will be located in Naples, Florida. Mr. Amtower reported that his department is on the National CERT conference planning committee, and have secured the 2020 national conference to be held in Missouri (city yet unknown). Mr. Amtower noted that his department is involved in helping the Christian County Health Department as well as other entities in active shooter exercises. Mr. Amtower then asked about a server that had been moved by PC Net from his department over to the Historical Courthouse, and asked if it could be addressed. The Commission thanked Mr. Amtower and Ms. Mitchell for their quarterly Emergency Management report.
