The Commission met with presenters Sheriff Brad Cole and Alicia Monsanto in regards to a bid opening for duty vests. Six bids were received, which were from GT Distributors based in Austin, Texas; Zenn Group based in Concord, North Carolina; Southern Uniform and Equipment based in Carthage, Missouri; Aspetto based in Fredericksburg, Virginia; Anchor Tactical Supply based in Springfield, Missouri; and LE Upfitter based in Olathe, Kansas. Sheriff Cole reported that all vendors met the specifications of the bid, with the exception of Zenn Group. Presiding Commissioner Weter entertained a motion to entertain Sheriff Cole next Monday, May 7, 2018, for a presentation of his bid recommendation.

Discussion - 04-30-18-4 Bid Opening Washer Dryer for Jail

Attendees: Alicia Monsanto, Sheriff Brad Cole, Sydni Moore with the Christian County Headliner, Michael Pratt and Tim Chamberlain with John Morris Equipment and Supply, Captain Richard Ramage

The Commission met with presenters from the Sheriff's department in regards to a bid opening for a washer and dryer for the jail. One bid was received, which was from John Morris Equipment and Supply based in Springfield, Missouri. The bid included a Primus Washer Extractor in the amount of \$8,800.00, with an additional charge for a hard mount base of \$536.25. The bid also included a 75-pound gas dryer in the amount of \$4,778.20. Both items met the bid specifications. The total cost for both washer, dryer, hard mount, and installation is \$14,364.95. Discussion was then held about the possibility of a state bid being considered, and Presiding Commissioner Weter entertained a motion to discuss this item on Monday, May 7, 2018 in order to compare the bid received with a state bid, and make a decision at that time.


