The Commission met with presenters from Paragon Architecture in regards to construction on the Circuit Court building. Mr. Erwin noted that it had been requested of Paragon to change the key locks in the detention door frames from manual to electric. To accomplish this, new door frames and hardware will have to be purchased and installed. Mr. Erwin noted that the cost to do so would be approximately \$28,000.00. Mr. Erwin also noted that a request has been made to enhance the security room to be a control center. Western Commissioner Bilyeu noted that the system as designed with manual locks is sufficient, and at this point does not want to entertain change orders. Presiding Commissioner Weter noted that there were several thorough discussions with the stakeholders in the planning and development stages of this project, and this request is not timely. Presiding Commissioner Weter announced his willingness to entertain a motion to grant the \$28,000.00 change order, but noted that if no motion was made, nothing will be changed. No motion was made. There was then discussion about authorizing Paragon Architecture and/or DeWitt & Associates to defer any future requests to the County Commission, in order to keep construction on schedule. It was noted that all of the buildings fall under the care of the Commission. Western Commissioner Bilyeu moved that as requests for changes come in and are processed appropriately by Paragon Architecture and DeWitt & Associates, let it be known that it will not progress beyond the initial stage before the authorization of the Commission.
