The Commission met with presenters from Paragon Architecture and DeWitt & Associates in regards to construction progress and decision items, that being holding cells, electrical locks, speakers, and integration of systems. Mr. Younglove presented the Commission with Pay Application No. 7, in the amount of \$674,854.19. Presiding Commissioner Weter entertained a motion to refer Pay Application No. 7 to the Christian County Auditor for her review and approval.

Discussion - 06-7-18-4 Construction Progress and Decision Items

Mr. Erwin recapped last week's stakeholder meeting, in which schematics and other information were disseminated to the Ozark Fire Protection District, Midwest Public Risk, and other applicable parties. Discussion was held in regards to a meeting with Kevin Jones (Simplex Grinnell) held after the contract reward of Bid Package No. 3, in which suggestions were made about revising the design to provide a high level of integration between access control, camera surveillance, intercoms, electrical door systems, at a cost of approximately \$153,000.00. Mr. Parr with Midwest Public Risk noted that MPR would like to be more involved with the project, to help determine the best mitigation now to help with liability later. Presiding Commissioner Weter asked Mr. Parr if the building is constructed as designed, would it meet applicable codes? Mr. Parr answered yes, however, if electrified locks are not installed it will cost more because of increased staffing costs (salary and workman's compensation exposure). Mr. Rooney noted that since the holding cells will be occupied at times by federal inmates, Simplex Grinnell has proposed a system for consideration to help alleviate liability. Mr. Erwin noted that the project is currently under budget, so there is allowance for contingencies. Mr. Long suggested that the holding cells be fully grouted in order to meet code. Sheriff Cole noted that the staffing matrix that was developed from the beginning of the Circuit Court Building project is based upon having electronic locks, and expressed concern that without electronic locks the possibility existed of co-mingling of juvenile and adult offenders. Mr. Barnes agreed. Western Commissioner Bilyeu noted his support of installation of the dual security integrated system proposed by Simplex Grinnell, in order to alleviate staffing costs in the future, with the hope that the total project cost can be within the Guaranteed Maximum Price. Eastern Commissioner Phillips agreed, saying that the system will pay for itself within two to three years. Presiding Commissioner Weter entertained a motion to authorize Paragon Architecture and DeWitt and Associates to present the Commission with a firm, fixed cost to consider on a date to be determined.
