It was noted that some Sheriff's office staff would move into the vacated space. Mr. Erwin noted that approximately \$85,000.00 has already been allotted to allow the reconfiguration of shifting offices. Brief discussion was held in regard to the control offices in both the Judicial Center and the Circuit Court Building, and it was noted that additional licensing fees would be required to link said rooms together. Captain Koch noted that the Judicial Center control room will not require additional personnel. No action was taken by the Commission at this time.


