Mr. Teague expressed that Auditor Amy Dent suggested using funding for the repair out of the Land and Building Improvement fund. Presiding Commissioner Weter entertained a motion to authorize this emergency proposal and then complete the proper documentation to validate that this has been handled in accordance with RsMO 50.780 regarding Emergency Procurement. The vote carried by acclamation. Emergency session was terminated.

The Commission met with presenter Jacklyn Aldrich of Chadwick Schools in reference to a Transportation Alternatives Program (TAP) Grant for the purpose of constructing sidewalks along Hwy 125 between Rose Avenue and Chadwick School on the east side of the Highway. Ms. Aldrich gave some history on the grant. It was noted that the area in question is on a MoDOT right-of-way. Ms. Aldrich noted that the grant requires an engineer to be an LPA on the project. Presiding Commissioner Weter expressed concern that the County could incur 80% of the cost of the project, as County Counselor Housley noted that the County's financial liability would not be limited. Discussion was held, and Christian County Highway Administrator Miranda Beadles expressed her concerns about the project, saying that as the applicant Christian County would bear the sole responsibility of the grant, therefore if something falls through or the project goes over budget the County will have marks against it when applying for grants in the future. Ms. Beadles expressed concern about being assigned the task of LPA as she's never seen design plans or an updated estimate, and said if the County is going to take this on she'd like to be more involved in order to have someone from the County looking out for its best interest. Ms. Beadles also mentioned maintenance of the sidewalk, saying that MoDOT doesn't want to maintain it. Ms. Aldrich noted that the school plans to maintain the sidewalk. Ms. Beadles suggested that the resolution in relation to this project be altered in order to limit the County's financial and project liability. Western Commissioner Bilyeu suggested that Ms. Aldrich gather information related to the project and give it to Highway Administrator Beadles and Counselor Housley so that a resolution could be drafted with clear lines of delineation and limitation of involvement. Presiding Commissioner Weter entertained a motion to ask Highway Administrator Beadles to consult with Counselor Housley so that he may prepare a document

inclusive of the items suggested, and to have it back to the Commission by Thursday, November 1, 2018.
