The Commission met with presenter Pam Duitsman, County Engagement and Community Development Specialist with MU Extension, for her monthly update. Ms. Duitsman reviewed their impact over the 2018 year and goals for 2019. MU Extension will be working on several targets including: increasing the number of high school graduates participating in post-secondary education (from the current 51% to 60%), collaborating with their partners to improve Missouri's national health ranking from 40th to 25th, and improving the economy of Missouri by more than doubling their economic impact from \$945 Million to \$2 Billion over the next 10 years. Walt Martens, Council Chair, discussed improving communication between MU Extension and the County, suggesting a Commissioner be present at their monthly meetings. Presiding Commissioner Phillips entertained a motion to approve Ms. Duitsman's monthly update as presented.
