LEASE AGREEMENT

THIS LEASE AGREEMENT is made and entered into this <u>here</u> day of <u>here</u> day of <u>here</u> day of <u>here</u> day of <u>here</u> by and between CHRISTIAN COUNTY, MISSOURI, by and through its County Commission (hereinafter "Christian County") and the CHRISTIAN COUNTY UNIVERSITY OF MISSOURI EXTENSION, by and through its Council (hereinafter "MU Extension").

- 1. <u>Lease of Premises.</u> Christian County hereby leases to the MU Extension certain premises located at 202 West Elm Street, Ozark, Christian County, Missouri, formerly occupied by the Christian County Juvenile Office. The MU Extension accepts these premises and agrees to occupy them in accordance with the terms of this Lease Agreement (hereinafter the "Agreement").
- <u>Term.</u> The term of this Agreement shall run and be in full force and effect for the period commencing on the _____ day of _____, 2019, and ending on the _____ day of _____, 2020. This Agreement shall renew automatically for successive one-year terms, on the same terms and conditions as stated in this Agreement, unless terminated as herein provided, or modified by documents signed by both parties.
- 3. **Termination.** Either party may terminate this Agreement upon giving at least ninety (90) days advance written notice to the other party. In the event of such termination, the effective date of termination shall be the end of the current lease year. This Agreement may also be terminated for breach or violation of any of its terms or conditions, provided that thirty (30) days advance written and opportunity to cure is provided to the other party. If the breach is not cured within a thirty (30) day notice period, this Agreement shall terminate at the end of the thirty (30) day notice period.
- 4. Use of Premises. The Premises shall be used by the MU Extension council and staff to carry out extension programs and activities in Christian County as provided in Sections 262.550 to 262.620, RSMo. The premises may not be used for any other purpose unless agreed in a writing signed by both parties.
- 5. <u>**Rent.**</u> The MU Extension shall not be obligated to pay Christian County rent for the premises because its services further the welfare of the citizens of Christian County.
- 6. Insurance.
 - (a) At all times throughout the term of this Agreement, MU Extension shall, at its own cost and expense, pursuant to country appropriations which provides for this expense, provide the following insurance coverage:
 - (i) Liability. Comprehensive public liability insurance against claims for personal injury, death, or property damage occurring in connection with the use and occupancy of the Premises and the improvements thereon, with such limits up to the statutory liability damage caps for Missouri public entities calculated by the Missouri Department of Insurance as of January 1 each calendar year and published annually in the Missouri

Register pursuant to Section 537.610, RSMo. The policy of liability insurance MU Extension agrees to provide and keep in full force during the term of its lease of the Premises shall, during the balance of the 2019 calendar year, provide coverage with limits of liability not less than ONE MILLION AND NO/100 DOLLARS (\$1,000,000.00) and TWO MILLION AND NO/100 DOLLARS (\$2,000,000.00) aggregate for all claims arising out of a single occurrence with respect to injuries, and/or death of any one person in a single accident or occurrence and an amount of not less than ONE MILLION AND NO/100 DOLLARS (\$1,000,000.00) for all claims to property arising out of a single occurrence.

- (ii) Unless otherwise agreed to in writing, Christian County shall insure the Premises for physical damage and MU Extension shall insure its personal property housed in the Premises for physical damage.
- (b) <u>Policies.</u> All policies shall contain a clause that the insurer will not change or cancel the insurance without first giving the County thirty (30) days prior written notice. The policies shall name Christian County as an additional named insured. If required, the policies shall be endorsed with a copy of said endorsement provided to Christian County.
- 7. Liability. For purposes of this agreement, to the extent not covered by sovereign immunity under Federal, State, or municipal law, the MU Extension hereby agrees to assume responsibility for the liabilities imposed by law on its officials, employees, agents, and contractors, and Christian County hereby agrees to assume responsibility for the liabilities imposed by law on its officials, employees, agents, and contractors. Each party to this Agreement shall be responsible for its own actions in providing services under this Agreement and shall not be liable for any civil liability that may arise from the furnishing of the services to the other party.

Christian County shall not be liable to MU Extension or the agents, guests, or employees for any damage to them or their persons or property, by theft or burglary, water, rain, snow, ice, sleet, fire, explosion, frost, storm, and accidents or by breakage, stoppage, or leakage of water, gas, heating and sewer pipes, electrical wiring or current, or plumbing upon, about, or adjacent to the Premises, or for any negligence of others that may cause damage of character whatsoever, unless such damage is caused by Christian County's gross negligence. This language is not intended to act as a waiver or limitation of the MU Extension's or Christian County's rights with regard to sovereign immunity under Federal, State, or municipal law.

 Indemnification. Except for damage or injury caused by the willful act or omission of Christian County, its agents or employees, and subject to the provisions of Missouri law, including Section 537.600 and Section 537.610, RSMo., MU Extension will indemnify, defend, and hold Christian County, its agents and employees harmless from any and all liability for injury to or death of any person, or loss of or damage to the property of any person, and all actions, claims, demands, costs (including, without limitation, reasonable attorney fees), damages or expenses of any kind arising therefrom which may be brought or made against Christian County or which Christian County may pay or incur by reason of the use, occupancy, and enjoyment of the Premises by MU Extension, its agents or employees. Christian County and MU Extension further agree that the County Commissioners, and the government of Christian County, Missouri, in general, and all of their officials, deputies, agents, and employees, are relying on, and do not waive, intend to waive, or limit any of their rights and/or defenses with regard to governmental, sovereign or official immunity as provided by the Missouri common law or any state or federal statute or constitution.

9. Services. Christian County shall furnish to the Premises for MU Extension's regular business operations subject to outages beyond Christian County's control and the provisions herein, electricity, sewer, air conditioning and heat, water for lavatory and drinking purposes, and trash service provided MU Extension places its trash in a receptacle to be picked up by county maintenance workers. Christian County shall provide restroom facilities and soap and paper products that would normally be in the restroom facilities. MU Extension will take care of cleaning their own offices and place their trash in a large receptacle in the front foyer. County Maintenance will clean the hallways and the bathrooms and take out the garbage from the large receptacle.

The amount and/or degree of heat or air conditioning to be furnished shall be the amount determined to be appropriate in the reasonable discretion of Christian County and for MU Extension's reasonable and comfortable occupancy of the Premises under normal business operations. MU Extension shall comply with all the rules and regulations which Christian County may reasonable establish for the proper functioning and protection of the air conditioning, heating, electrical, and plumbing systems.

(a) Lighting and Electrical. Christian County shall further provide normal office lighting for the Premises and common areas which shall not include any special or unique lighting for MU Extension. Subject to the provisions otherwise stated herein, Christian County shall also furnish electricity to the Premises. MU Extension's use of such electricity shall not at any time exceed the capacity of the electrical conductions or equipment installed in or servicing the Premises. MU Extension shall make no alteration or addition to any electrical equipment, wiring, or installation without the prior written consent of Christian County in each instance and then at MU Extension's sole cost. All such alterations or additions must be installed by licensed contractors to code and coordinated with County Maintenance (Richard Teague). MU Extension will e-mail Richard Teague a request for a change and he, with MU Extension representation, will present request to Commissioners for approval. Repairs and maintenance will be the responsibility of the County, including all alterations and installations made by MU Extension.

- (b) <u>Telephone and Additional Services</u>. Expenses related to telephone, internet, and other communication mediums, if any, shall be the responsibility of MU Extension pursuant to county appropriations, which covers costs for these items. Moreover, MU Extension shall pay for all additional services or utilities provided by Christian County to MU Extension not uniformly furnished to the Premises, pursuant to county appropriations.
- (c) <u>Warranty of Services</u>. Christian County offers no warrant of any services provided by Christian County pursuant to this Agreement and Christian County shall not be liable for any interruption of such services. No interruption of service shall be deemed an eviction or disturbance of MU Extension's use and possession for the Premises or render Christian County liable to MU Extension for damages or relieve MU Extension from performance of MU Extension's obligations under this Agreement. Christian County shall use reasonable efforts to restore interrupted services upon notice from MU Extension.
- 10. <u>Alterations.</u> MU Extension shall not make alterations or additions to the Premises without first obtaining written consent from Christian County. All such alterations or additions must be completed by licensed contractors to code and coordinated with County Maintenance (Richard Teague). MU Extension will e-mail Richard Teague a request for a change and he, with MU Extension representation, will present request to Commissioners for approval. Repairs and maintenance will be the responsibility of the County, including all alterations and installations made by MU Extension.

Once written consent is obtained, MU Extension may, at its own expenses, either at the commencement of or during the Term of this Agreement, make alterations and/or additions to the Premises. Christian County covenants not to unreasonably withhold approval of alterations and/or additions proposed to be made by MU Extension; *however*, approval by Christian County shall not be construed as a waiver of any term or requirement herein, including without limitation, the Americans with Disabilities Act. A County inspector will determine current adherence of the building to the Americans with Disabilities Act, prior to MU Extension's occupation of the premises. MU Extension may also, at its own expense, and consistent with the design and structural integrity of the Premises, install such counters, partitions, walls, shelving, fixtures, fittings, machinery, and equipment ("Installations") upon or within the Premises as reasonably necessary for the conduct of its business consistent with the permitted use hereunder, subject to the prior written approval of Christian County not to be unreasonable withheld. Movable shelving and partition walls may be installed without Christian County approval, provided that on any expiration or termination of the Agreement, MU Extension shall be responsible for restoring the Premises to its original condition as existed prior to such Installations. At any time prior to the expiration or earlier termination of the Agreement, the Premises shall be restored by MU Extension at its expense to the same condition as existed as of the Commencement Date, and prior to the making of such movable alterations, ordinary wear and tear excepted. All alterations, additions, or Installations not so removed by MU Extension shall become the property of Christian County without liability on Christian County's part to pay for the same. Christian County's approval shall be deemed to be reasonably withheld if (but not limited to) such alterations, additions, or installations are not compatible with the structure of the Premises, result in any

increase in insurance premiums (unless MU Extension pays or agrees to pay such increase), or otherwise adversely affect the value or utility of the Premises, or any part thereof.

- 11. <u>Maintenance and Repairs.</u> Christian County shall provide for all costs and expenses relating to the maintenance and repairs on the exterior and interior of the Premises occupied by the MU Extension, including but not limited to, the roof, outside walls (including glass), doors, plumbing fixtures, sewer, and water line services, and heating and cooling systems. Any such maintenance or repairs required as a result of the negligence or abuse of the Premises by the MU Extension, its agents, or signs, shall be the responsibility of the MU Extension. MU Extension shall maintain in good condition the interior surfaces, reasonable wear and tear excepted. In accordance with the minutes of 4-22-19 Commission meeting, MU Extension will submit a list enumerating items in need of clarification. Such things include but are not limited to cleaning of external glass; repair/replacement of external awnings; external signage.
- 12. <u>Assignment and Subletting.</u> MU Extension shall not assign or sublease any part of the leased Premises.
- 13. **Damage of the Leased Premises.** In the event the leased Premises are totally destroyed or rendered unusable by fire or other casualty, or that the remainder is not reasonably usable for MU Extension's purposes, this lease shall terminate and unless the leased Premises are repaired by Christian County, at Christian County's sole discretion, and made fit and useable within sixty (60) days from the occurrence of said damage.
- 14. Entire Agreement. This Agreement contains the entire Agreement of the parties. No modification, amendment, or waiver of any of the provisions of this Agreement shall be effective unless in writing specifically referred to and signed by both parties.
- 15. <u>Venue</u>. This Agreement and every question arising hereunder shall be construed or determined according to the laws of the State of Missouri. Should any part of this Agreement be adjudicated, venue shall be proper only in the Circuit Court of Christian County, Missouri.
- 16. <u>Notice.</u> All notices required or permitted hereunder are required to be in writing, and may be given by first class mail, addressed to the parties at the addresses listed above. The date of delivery of any notice shall be the date falling on the second full day after the date of its mailing.
- 17. <u>Authorization</u>. The parties are authorized to enter into this Agreement, and each of the undersigned persons are authorized to execute this Agreement on behalf of the party for whom the Agreement was signed.
- 18. <u>Compliance With Section 70.220. RSMo.</u> The parties acknowledge that this Agreement is within the scope of each of their powers, and that this Agreement has been approved by the governing body of each of the parties. This Agreement is entered into in compliance with Section 70.220, RSMo.

MU Extension Economic Profile: Christian County, Missouri¹

Prepared by Pam Duitsman, PhD; County Engagement and Community Economic Development

Christian County was the fastest growing county in Missouri and one of the fastest growing in the nation between 2000 and 2010, and became more suburban due to close proximity with Springfield, MO. Population and job opportunity in the county continues to grow.

Christian County is growing and its cost of living is below the national average.

- In 2018, an estimated 86,648 people lived in Christian County, up over 8% percent from its 2013 population. This growth outpaced the growth rates of both state (2%) and nation (4%).
- The Cost of Living Index is lower in Christian County (91) than national average (100). Cost of living is comprised of six major categories: grocery items, housing, utilities, transportation, health care, and miscellaneous goods and services.
- At \$54,400 annually, Median Household Income in Christian County is ahead of state (\$49,600), but trails the nation (\$55,300).

The workforce is growing and serves neighboring cities

- In 2018, there were roughly 21,295 jobs in Christian County, an increase of 11% from 2013, and outpacing the growth rate for both the state (5%) and the nation (7%).
- Sixty-four percent of the county's 68,536 working age adults are in the labor force, above the state (62%) and nation (61%). Labor force participation in the county has remained fairly steady over the past 5 years.
- A number of Christian County workers commute to work outside of the county. Almost one-third of workers
 that live in Christian County work outside the county, primarily in Springfield/Greene County. To a lesser
 extent, workers from Christian County also commute to Branson/Taney County. Given its role as a bedroom
 community, the economic future of Christian County is closely tied to that of Springfield and Branson. In 2018,
 28% of the labor force commuted outside of the county.
- In 2018, Christian County had 40,541 Resident Workers. These workers live in the county, but are not
 necessarily employed there. This is helpful in demonstrating workforce availability and helping companies
 locate the talent they need. Companies are growing more interested in bedroom communities that have a
 labor pool they can tap into.
- Similar to the state of Missouri, Christian County has a higher number of veterans (6,109) than the national average, and slightly fewer millennial workers (aged 20-34).
- Retirement risk or those retiring soon -- is about average in Christian County compared to the national average. Around 24,000 are 55 or older.



Christian County, MO has 15,562 millennials (ages 20-34). The national average for an area this size is 17,694.

- Educational attainment in the county is similar to both State and Federal, with 25% of the population having some college, 8% having Associates degrees, 19% Bachelor's degrees, and 8% graduate or higher degrees.
- The average hourly earnings for all occupations in 2018 in Christian County was \$17.28. The Cost of Living Adjusted average hourly earnings for all occupations is \$18.99.
- The most common occupations in Christian County reflect the county's largest sectors.
 - Office and Administrative Support (2,817 jobs), Sales and Related Occupations (2,455 jobs), Food Preparation and Serving Related Occupations (2,156 jobs), Education, Training and Library² (1,781 jobs), and Construction and Extraction Occupations (1,739 jobs) groups had the largest employment.
 - Each of these groups experienced positive growth over the 2013-2018 period, reflecting their connection to the county's population trends.
 - Only two Occupation areas decreased during the 2013-18 period: Computer and Mathematical Occupations³ fell 12%, and Healthcare Support Occupations fell by 3%. Both are also lower than the state and national average for these occupations.

The economy is service-industry driven

- Locally-serving industries account for the majority of the county's employment. Employment in these sectors
 is tied directly to population trends. As a result, the county's continued population growth has led to similar
 growth in some sectors from 2013-18.
 - Government (which includes public schools approximately 2,180 jobs) is the county's largest employing sector, contributing 3,508 jobs in 2018.
 - Retail (2,917 jobs), Construction (2,386), Accommodation and Food Services (2,088), Professional Scientific and Technical Services (1,009), Administrative and Support and Waste Management and Remediation Services (811), and other services (1,562) are heavily influenced by population trends and have experienced growth since 2013.
 - The Arts, Entertainment, and Recreation Industry in Christian County stood out with 64% growth from 2013, and employing 323 in 2018.
- Christian County's export-oriented sectors account for fewer jobs overall than service sectors, but bring new money into the community (from county exports).
 - The export-oriented sectors include manufacturing (1,654 jobs), and transportation and warehousing (812 jobs). Both of these sectors contributed net new employment to Christian County over the past half-decade.
 - Transportation and logistics companies—including CRST International, USA Truck, Hogan Transports, Koch Trucking, J.B. Hunt Transport Services, and Nussbaum Transportation Services—were the most likely to post online job advertisements for positions in Christian County.
- Two-thirds of business establishments in the county have fewer than 10 employees. Only 3% of Christian County businesses have 50 or more employees.
- The Mining, Quarrying, & Oil & Gas Extraction Industry grew by 50% from 2013-2108, employing 102 in 2018.

¹This brief highlights some of the basic economic trends shaping Christian County, Missouri. This information draws on regional profiles developed by Economic Modeling Specialists International (EMSI)—a leading source of proprietary labor market information, and provided by University of Missouri Extension. This brief is not intended to provide definitive and comprehensive answers about the county's economy, but rather offer information to aid understanding of the population and economic trends shaping the county. Unless noted otherwise, estimates in this profile are for 2018 or 2017. ²Education, Training and Library Jobs: People employed in these occupations teach in public and private elementary and secondary schools, postsecondary institutions and provide services in public libraries. These areas are vital for quality of life, and the economic well-being of any region. Public libraries not only lend books but also act as community centers. ³Computer and Mathematical Occupations: comprises the following occupations: Computer and Information Research Scientists; Computer Systems Analysts; Information Security Analysts; Computer Programmers; Software Developers, Applications; Software Developers, Systems Software; Web Developers; Database Administrators; Network and Computer Systems Administrators; Computer Network Architects; Computer User Support Specialists; Computer Network Support Specialists; Computer Occupations, All Other; Actuaries; Mathematicians; Operations Research Analysts; Statisticians.





Urban Population, Percent by Tract, US Census 2010






Rural Population, Percent by Age Group






Rural Population, Percent by Race Alone





Median Household Income by Tract, ACS 2013-17





Workers Commuting Over 60 Minutes, Percent by Tract, ACS 2013-17






Unemployment, Rate by County, BLS 2019 - February



Average Monthly Unemployment Rate, February 2018 - February 2019







On-Time Graduation, Rate by School District (Secondary), EDFacts 2016-17





Cost Burdened Households (Housing Costs Exceed 30% of Household income), Percent by Tract, ACS 2013-17



Cost Burdened Households by Tenure, Total Christian County, MO








