Presiding Commissioner Phillips entertained a motion to approve all items listed on the consent agenda, which included approval of Christian County Commission’s regular session agenda for today, May 20, 2019 as published (said agenda was amended to include Sheriff’s Office grant approvals); a renewal of stormwater pipes and culverts with Metal Culverts, Inc., Viebrock Sales and Service, and UDS Pipe Supply LLC; and an agreement with Carey Danis & Lowe regarding opioid distribution data. There are no minutes or financials to address. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met with Sheriff Brad Cole regarding grant approval. The four grants presented are non-matching, fully-funded, and include Youth Alcohol Enforcement in the amount of \$2,804.40 (20-154-AL-031), DWI Saturation Enforcement in the amount of \$8,713.20 (20-154-AL-032), HMV Enforcement in the amount of \$10,751.10 (20-PT-02-030), and Computer Data in the amount of \$36,046.86 (20-M3DA-04-002). Presiding Commissioner Phillips entertained a motion to approve the appointment of Susie Ballard to the LERF Board and to approve the grants as presented by Sheriff Brad Cole. Western Commissioner Bilyeu so moved. Eastern Commissioner Robertson seconded the motion.


