

Regardless, all of the mapped Spring Crest Addition lies within the city limits of Ozark and within 6.02. <u>= no action taken on this part at all.</u>




in general, the mapped parcels do not match with the mapped PLSS

The mapped city limit and parcels do not always follow the annexation text – regardless of position with PLSS - example = Ozark 3053 "west 20 ft"

= I think there could be a fairly significant error in the deed text. The deed text states start at NE corner N1/2 NW1/4, 18-27-21, th W 568.53 to POB. To make this triangle fit where it was intended I show this distance should have been closer to 910 ft (+/-), or, perhaps they have the starting point wrong. You could have a 3rd party review it but bottom line is regardless of this I cut where the intended location was instead of the literal text (as I read it)


= as indicated, I cut the rectangle described out of 28.03 and added it to 30.01. However, there is also an adjacent part called 28.01.


1 - 1 do not know what the difference between 28.01 and 30.01 is (28.01 is also within the city)


2 – I didn't know for sure this new piece was to become 30.01 or maybe it should have been 28.01 = I deduced this

= on the triangle at the bottom, the <u>deed text</u> goes west 20 ft before heading NW. The mapped city limit and parcels do not. I matched the mapped city limits and parcels, over the deed text









= this deed text puts parcel 110515003008001000 into the city limits, so this parcel was cut from 6.01 and added to 6.02.
1 - there was quite a bit of difference between the mapped

parcel/city limits and the deed text = I went with the mapped parcel/city limit, for the most part.

2 - However, there was a portion along the NW side that I did differ from the mapped parcel/city limit. I went with the deed text so this does differ from their GIS. This was clearly included. In this case the mapped parcel/city limit should ultimately be amended to match this text.

At this point there remains a parcel included in the mapped city limit – 110515003001001000 – that is not yet in Part 6.02. I'm guessing a subsequent ordinance picks this up.

= part of 110725000000036000 went from 17.01 to 17.05 (inside Ozark city limits) but not all of the


parcel yet. Presumably another ordinance will pick up the rest.


Right now there is one small part where I went with the described PLSS aliquot part as the north city limit line where the present mapping has the city limit going with the parcel. As it is within road r-o-w it probably does not ultimately matter. The mapped parcels and the mapped city limit line are not matching here anyway so ultimate accuracy, to a degree, is somewhat moot.

There is a small part that they do not have mapped as within the city limit that I do think is covered by this deed text, so I included it. This is just a matter of interpretation.






