A quorum was established. Western Commissioner Bilyeu entertained a motion to approve all items listed on the consent agenda, which included approval of Christian County Commission's regular session agenda for today, August 22, 2019 as published, approval of Christian County Commission's regular session minutes from August 19, 2019, and approval of Certified Court Order 08-22-2019-01. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met regarding levy hearings for Common One Road District, Common Two Road District, and General Revenue. Clerk Kay Brown presented the prior year tax rate ceiling for Common One Road District as 0.1049, and the current year rate computed at 0.1026. Discussion was held, and Western Commissioner Bilyeu entertained a motion to leave the levy rate as is. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

Clerk Kay Brown presented the prior tax rate ceiling for Common Two Road District as 0.0000, and the current year rate computed at 0.0000. Clerk Kay Brown presented the prior tax rate ceiling for General Revenue as 0.2266, and the current year rate computed at 0.2241. Clerk Kay Brown suggested the current rate be reduced by 0.1701, making the levy rate 0.0540. Discussion

was held, and Western Commissioner Bilyeu moved that in light of the mandated Hancock Amendment the levy rate be reduced to 0.0540. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

Aye: Robertson, Bilyeu. Nay: None. Absent: Phillips. Abstain: None.



Aye: Robertson, Bilyeu. Nay: None. Absent: Phillips. Abstain: None.


